To the best of my knowledge, this pup is in good health at the time of delivery. The Buyer must have the above referenced dog examined by a licensed veterinarian within four (4) days of purchase. The expense of this examination is to be assumed by the Buyer. If the pup is found to be unsound it can be returned for refund of purchase price or a replacement pup of equal or greater value. Either one is at the Breeder's discretion. This is provided the pup is returned within the 4 day period and is accompanied by a letter from the examining veterinarian stating in what respect the pup is unsound. This guarantee is void should the Buyer not have the pup examined within the 4 day period. There will be no refund by the Breeder for any reason but not limited to: hernias, retained testicles, allergy, mortality, landlord's disapproval, disagreement of family or any other problems not related to health. **TO INCLUDE THE BUYER CHANGING HIS/HER MIND.** Nor for illness caused by neglect, exposure to weather, injury, choking, poisoning, etc. no warranty or guarantee is made to the disposition, life-span, color, size, show quality, or breeding quality of any puppy.

THE BREEDER WILL NOT BE LIABLE FOR ANY EXPENSES INCLUDING BUT NOT LIMITED TO: ANY VETERINARY BILLS, TRANSPORTATION, OR OTHER EXPENSES. Should there be a life threatening genetic defect, having been there since birth, and diagnosed by a licensed veterinarian, the Breeder will refund or replace the puppy, limited to one year from the date of purchase. No refund or replacement will at any time be made on a deceased puppy until an autopsy is performed to determine cause of death. Such an autopsy must be performed by an accredited institution set up for such procedures such as Colo. State University (CSU). Autopsies performed by a local veterinarian will not be accepted. All expenses will be paid by the Buyer. The results of the autopsy will accompany any request for a replacement or refund. The Breeder must be notified immediately upon discovery of a genetic defect. The Breeder reserves the right to have the dog examined by a veterinarian of her choice for a second opinion. In the case of a discrepancy between a genetic and an acquired condition the Breeder has the sole and absolute final decision. Should the pup be returned, the Breeder will only refund the purchase price of the pup, not including transportation, vet check, gas, air fare, supplies or replace the pup with one of the Breeder's choice. **NO VET BILLS WILL BE REIMBURSED. ACCEPTANCE OF THE PUPPY CONSTITUTES ACCEPTANCE OF THIS CONTRACT IN FULL.**

IMPORTANT: If this pup is micro-chipped by the Breeder and the Buyer does not register the number in his/her name and the dog is found, ownership of the pup/dog goes back to the Breeder, with no refund to the Buyer. When the Breeder has possession of the pup/dog the Breeder will make every effort to contact the Buyer if the Buyer has kept the Breeder up to date with name and address.
