This dog has been vaccinated and wormed, and to the best of my knowledge is in good health at the time of the sale. THIS CONTRACT IS VALID FOR ONE YEAR FROM DATE OF BIRTH OF THIS PUPPY FOR ORIGINAL BUYER ONLY. NOT TRANSFERABLE. 1. <u>The Buyer has been informed that this contract is for a Pet puppy and therefore, MUST be spayed or neutered by 6 months of age. Proof of spay or neuter, (to include documented microchip number of above puppy in this contract) by a licensed veterinarian, <u>MUST be sent to the Seller within 5 days of surgery or this contract will be VOID.</u> Should the buyer decide to breed this puppy, even one time, the balance of the breeding price shall be paid to the seller. No papers will be provided if the seller is not paid the balance of the breeding price before the breeding occurs.</u>

The Buyer has 4 business days from the date Buyer picks up the puppy to have this dog examined by a licensed veterinarian. 2. A copy of this exam will be emailed to the Seller within 1 day of the appointment. Failure to do so will VOID this health guarantee. The expense of this examination is to be assumed by the Buyer.

If the dog is found to be unsound the seller must be notified immediately. <u>The dog will be returned within 72</u> <u>hours of the vet appointment and accompanied by a letter from the examining veterinarian stating in what</u> **respect the dog is unsound.** I will replace the puppy with a puppy of equal value when one is available.

No refund or replacement will be given on a deceased puppy without a full Necropsy performed to determine cause of death. The expense of this Necropsy is to be assumed by the Buyer.

Should there be a life-threatening genetic defect diagnosed by a licensed veterinarian, the Seller will replace the dog with another dog of the same quality for the price of the puppy alone. The Seller reserves the right to have the dog examined by a veterinarian of her/his choice for a second opinion. This means the dog/puppy must be returned within 72 hours of the vet exam or the contract/health guarantee is VOID. All return expenses are assumed by the Buyer. In case of a discrepancy between a genetic and acquired condition, the Seller has the sole and absolute final decision.

3.If the Buyer has the puppy put down without notifying me before doing so, this contract is **VOID**. No refund or replacement will be given on a deceased puppy without a full Necropsy performed to determine cause of death.

There will be NO WARRANTY OR REFUND by the Seller for any reason, but not limited to allergy, mortality, landlord's disapproval, disagreement of family, or any other problems not related to health. TO INCLUDE THE BUYER CHANGING HIS/HER MIND, nor for illness caused by neglect, accident, exposure to weather, injury, choking, poisoning, or for disease caused by lack of the Buyer keeping up the vaccinations, etc.

THE SELLER WILL NOT BE LIABLE FOR ANY EXPENSES INCLUDING BUT NOT LIMITED TO: ANY **VETERINARY BILLS**, TRANSPORTATION, OR GAS, AIRFARE OR SUPPLIES.

<u>A HEALTH RECORD including, wormings and vaccinations and labels off the vials is provided with this puppy</u> <u>A RABIES BROCHURE describing the importance of rabies vaccinations is provided with this puppy</u>.

BUYER AGREES: to release from legal responsibility, forever, with regard to the development of this puppy. No warranty or guarantee is made to the disposition, life-span, size, color, show quality, bite, retained testicles, hernias, body structure, coat, ancestor's genetics or breeding ability of any pup/dog.

NOTES: 4. This puppy is MICROCHIPPED. Registration of the chip is the responsibility of the buyer. Failure to register the chip **VOIDS** this contract. You may use: <u>www.buddyid.com</u> = 24.95/lifetime or <u>www.foundanimals.com</u> = FREE/ LIFETIME.

ADDITIONAL NOTES: IF THIS DOG IS MICRO-CHIPPED BY THE SELLER AND THE BUYER CANNOT BE LOCATED WHEN THE DOG IS FOUND, OWNERSHIP OF THE DOG GOES BACK TO THE SELLER WITH NO REFUND TO THE BUYER. WHEN THE SELLER HAS POSSESSION OF THE DOG THE SELLER WILL MAKE EVERY EFFORT TO CONTACT THE BUYER IF THE BUYER HAS KEPT THE SELLER UP TO DATE WITH NAME, ADDRESS AND PHONE NUMBERS.
